# THE RIGHT DRUG AT THE RIGHT PRICE

## Effective July 1st, 2022

### **New programs**

UM program, therapy class or medication descriptions are included below, along with the specific medications targeted by these new UM programs. Please see the corresponding symbol for the type of UM program that applies.



#### **Prior Authorization**

A process to ensure appropriate prescribing and use before a drug will be covered. Coverage may be approved after certain criteria are met.



## **Quantity Limits**

The maximum amount of drug allowed for each fill. Quantity limits are based on the number of days or number of units (pills, capsules, ounces, etc.). Limits promote safe, cost-effective drug use reducing waste and overuse.



#### **Step Therapy**

A process that requires trying another drug that may be more safe, clinically effective and, in some cases, less expensive, before a more expensive drug is approved.

Acute Migraine Agents – used to treat migraines, a headache of varying intensity accompanied by nausea and sensitivity to light and sound	Elyxyb	PA QL
Attention Deficit Hyperactivity Disorder (ADHD) – a condition that includes a combination of persistent problems such as difficulty paying attention, hyperactivity, and impulsive behavior	Amphetamine ER suspension (branded generic of Adzenys ER)	QL
<b>Antidepressant</b> – used to treat depression and other disorders, such as anxiety, obsessive-compulsive disorder, and neuropathic pain	Citalopram capsule	QL ST
	Buproprion XL	QL
Angiotensin Receptor Blocker (ARB) Renin Inhibitors – used to treat high blood pressure	Valsartan solution	QL ST
Baclofen – used to treat muscle spasms	Fleqsuvy (authorized generic of Ozobax)	PA QL
<b>Biologic Immunomodulators</b> – used to treat conditions like rheumatoid arthritis, psoriasis, Crohn's disease, and ulcerative colitis	Rinvoq 45 mg tablet	PA QL
Constipation Agents – used to treat and prevent constipation	Ibsrela	PA QL
Hereditary Angioedema – a rare genetic disease that causes episodic attacks of swelling	Takhzyro prefilled syringes	PA QL
Insomnia Agents – used to help with problems falling and/or staying asleep	Quviviq	QL ST
Ophthalmic Immunomodulators – used to treat dry eyes	Verkazia	PA QL
Opioids Immediate Release (IR) New to Therapy (NTT) with Daily Limit – short-acting central nervous system pain medicines	Seglentis	QL
Self-administered Oncology Agents— a group of medicines to treat cancer that are a tablet or capsule form and can be taken by mouth	Lenalidomide, Vonjo	PA QL
Somatostatin Analogs – used to reduce the production of various hormones in the body	Lanreotide (branded generic of Somatuline Depot)	PA QL

Interleukin (IL) – 13 Antagonist – used to treat atopic dermatitis (a condition that makes the skin red and itchy)	Adbry	PA QL
Cibingo – used to treat atopic dermatitis (a condition that makes the skin red and itchy)	Cibinqo	PA QL
Pyrukynd – used to treat hemolytic anemia (a condition that results in low red blood cell counts)	Pyrukynd	PA QL
<b>Recorlev</b> – used to treat high cortisol levels in patients with Cushing's syndrome (a condition where the body makes too much of the hormone cortisol)	Recorlev	PA QL
<b>Tarpeyo</b> – used to reduce levels of protein in the urine caused by a type of kidney disease	Tarpeyo	PA QL
