What is the overall deductible?	\$4,600 single / \$9,200 family medical and drug in-network \$10,000 single / \$20,000 family medical and drug out-of-network	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. This <u>plan</u> has a non-embedded <u>deductible</u> . If you have other family members on the <u>plan</u> , the overall family <u>deductible</u> must be met before the <u>plan</u> begins to pay. The single <u>deductible</u> applies to single coverage only.
Are there services covered before you meet your deductible?	Yes. Well child care, prenatal care and in-network preventive care services are covered before you meet your deductible.
